- She might be interested in partnering with HLCD for future Health Literacy Month initiatives.
- They are aiming to designate June 17 as Health Literacy Advocacy Day, pending confirmation.
- We are exploring a concurrent resolution that both the House and the Senate would sign.
- Greg would be the only person required to speak during the resolution
- Still waiting to hear from the Governor's office about the proclamation. They have confirmed receipt.

- Payer Event
 - We are thinking about having a payer panel during HL month
 - What do we want the outcome of the panel to be?
 - Private insurance companies, Medicare, Medicaid, and sometimes large employer-based plans.
- Badging Process for Health Literacy Champions
 - What would these tiers of engagement and support look like for organizations that might be interested in being recognized and supported by HLCD?
 - Badges will be for public display.
 - Organizations must attend at least 50% of HLCD meetings.
 - We need to determine how many of the proposed activities would be required to earn a Tier 1 badge.
